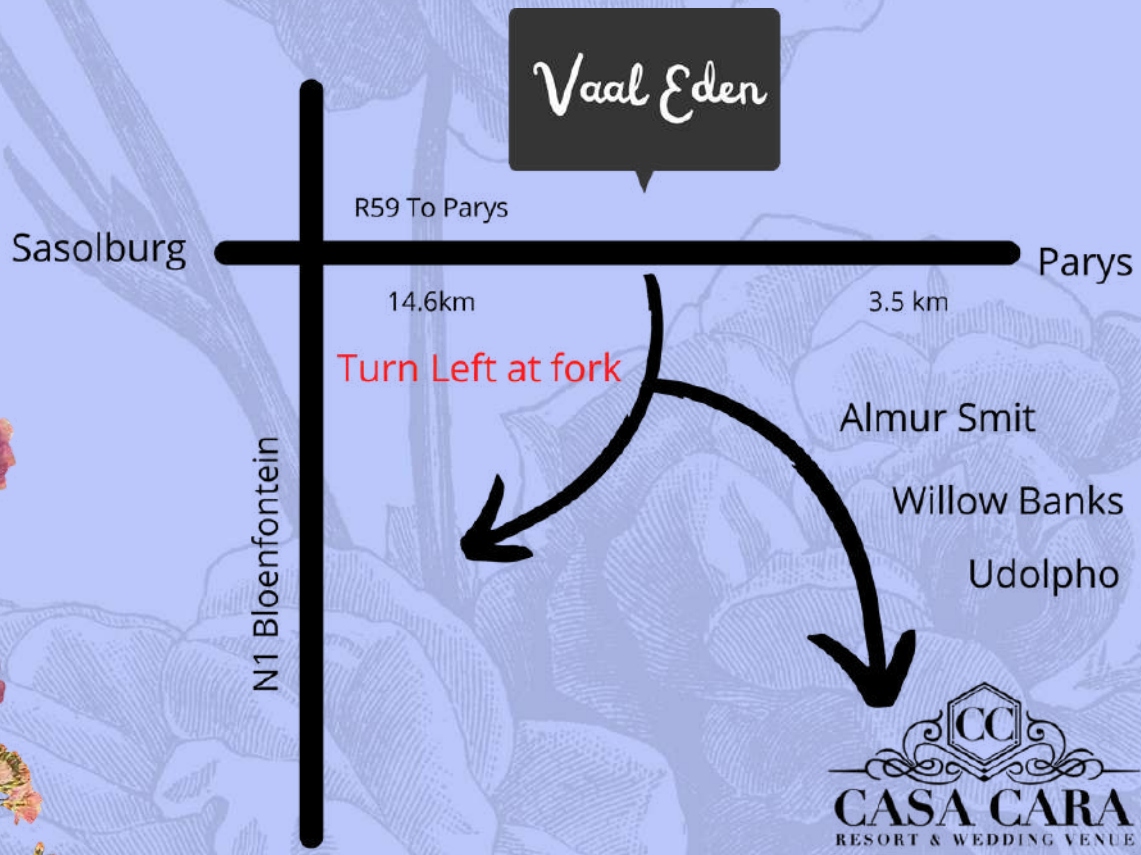

## FROM JOHANNESBURG:

COMING TO PARYS FROM JOHANNESBURG, YOU WILL BE TRAVELLING IN THE R59 PROVINCIAL ROAD. WHEN YOU SEE THE PARYS AIRFIELD ON YOUR LEFT, YOU ARE ABOUT 500M AWAY FROM THE VAAL EDEN ROAD. TURN RIGHT ONTO THE VAAL EDEN ROAD. THIS BECOMES A DIRT ROAD AND ROUGHLY 300M FURTHER THERE IS A TURNOFF TO THE LEFT. FOLLOW THIS DIRT ROAD FOR ABOUT 3.6KM. CASA CARA LODGE'S ENTRANCE WILL BE ON YOUR LEFT.

## FROM PARYS:

TRAVELLING FROM PARYS YOU WILL BE TRAVELLING ON THE R59 PROVINCIAL ROAD. TURN LEFT ONTO THE VAAL EDEN ROAD APPROXIMATELY 3.5 KM OUTSIDE OF PARYS. THIS BECOMES A DIRT ROAD AND ROUGHLY 300M FURTHER THERE IS A TURN-OFF TO THE LEFT. TAKE THE LEFT AND FOLLOW THIS DIRT ROAD FOR ROUGHLY 3.6KM. CASA CARA LODGES ENTRANCE WILL BE ON YOUR LEFT.

# Wedding Contract

A DEPOSIT OF R10 000 IS PAYABLE TO CONFIRM YOUR BOOKING AS WELL AS YOUR WEDDING DATE. THE DEPOSIT WILL BE USED FOR PART PAYMENT OF YOUR FINAL ACCOUNT (BREAKAGE DEPOSIT) AND WILL SERVE AS CONFIRMATION THAT YOU ACCEPT AND ARE LEGALLY BOUND BY THIS CONTRACT.

IN THE EVENT THAT A FUNCTION/WEDDING IS CANCELLED: THE R10 000.00 DEPOSIT IS NON-REFUNDABLE REGARDLESS OF THE TIME PERIOD BEFORE THE DATE OF THE FUNCTION.

MINIMUM OF 80 GUESTS (EXCEPT JUNE, JULY & AUGUST)

IF A DATE IS PROVISIONALLY BOOKED, WE WILL ONLY KEEP THE DATE OPEN FOR 14 DAYS. TO CONFIRM THE DATE THE DEPOSIT MUST BE PAID IN FULL WITHIN THOSE 14 DAYS. IF THE DEPOSIT IS NOT PAID IN FULL BY THE END OF THIS PERIOD, WE WILL AUTOMATICALLY CANCEL THE BOOKING AND THE DATE WILL BE GIVEN TO THE NEXT CLIENT.

THE DEPOSIT WILL BE KEPT AS SECURITY TILL AFTER THE FUNCTION/WEDDING AND WILL BE PAID BACK WITHIN 21 WORKING DAYS.

A VENUE FEE OF R1500.00 PER HOUR WILL BE CHARGED AFTER 24:00 PM. THIS WILL BE ADDED TO YOUR ACCOUNT AT THE END OF THE FUNCTION (THE VENUE WILL CLOSE STRICTLY AT 02:00AM)

BALANCE OF THE FINAL ACCOUNT MUST BE PAID 14 DAYS PRIOR TO THE WEDDING/FUNCTION DATE. LATE PAYMENT FEES WILL BE ADDED (20% OF INVOICE PRICE) IN THE EVENT OF LATE PAYMENT.

# Catering

WE HAVE OUR OWN CATERING SERVICE AND ALL CATERING MUST BE DONE BY CASA CARA RESORT & WEDDING VENUE. NO OUTSIDE CATERING IS ALLOWED. LEFTOVER FOOD MAY NOT BE TAKEN AFTER THE BUFFET HAS CLOSED.

## PRE-RECEPTION DRINKS AND SNACKS:

- IT IS RECOMMENDED THAT YOU SERVE PRE-RECEPTION DRINKS TO YOUR GUESTS AFTER THE CEREMONY WHILST THE PHOTO SESSION IS TAKING PLACE.
- ONE ALCOHOLIC OPTION AND ONE NON-ALCOHOLIC OPTION IS RECOMMENDED.
- DRINKS WILL BE SERVED AT THE VENUE.
- OWN RECEPTION DRINKS ARE NOT ALLOWED, PENALTY FEES WILL APPLY
- PLEASE DISCUSS ANY SPECIAL REQUESTS WITH US.

## BAR SERVICES:

- NO BEVERAGES OF ANY KIND MAY BE BROUGHT ONTO THE PREMISES WITHOUT CONSENT FROM MANAGEMENT.
- PENALTY FEES WILL APPLY AND YOU WILL BE ASK TO LEAVE THE VENUE
- PLEASE DISCUSS ANY SPECIAL REQUESTS WITH US.
- IF YOU WOULD LIKE TO BRING YOUR OWN WINE OR SPARKLING WINE, A CORKAGE FEE OF R50.00 PER BOTTLE WILL BE CHARGED.
- EXTRA WAITERS CAN BE ARRANGED AT AN ADDITIONAL R350.00 PER WAITER FOR THE EVENING.

## ACCOMMODATION:

- ALL ACCOMMODATION BOOKINGS ARE A MINIMUM OF A TWO-NIGHT STAY.
- 50% DEPOSIT IS REQUIRED TO CONFIRM YOUR ACCOMMODATION BOOKING.

# Setup and Cut off times:

- CASA CARA WILL DO THE TABLE SETUP FOR THE STANDARD FURNITURE, CUTLERY AND CROCKERY THAT IS INCLUDED IN THE PACKAGE (WE ARE NOT RESPONSIBLE FOR ANY DECOR SETUP).
- PLEASE NOTE THAT WE ARE NOT WEDDING PLANNERS
- DECOR, FLOWERS ETC. MUST BE DONE THE DAY BEFORE THE WEDDING (CUT OFF TIME: 17:00). THE RECEPTION AND CEREMONY AREA WILL NOT BE AVAILABLE AFTER 17:00 AND WILL BE LOCKED.
- PLEASE NOTE THAT WE DO NOT HAVE STAFF AVAILABLE TO HELP YOU SET UP. WE CAN ARRANGE EXTRA STAFF AT R250.00 PER DAY PER STAFF MEMBER. THIS WILL BE ADDED TO YOUR FINAL ACCOUNT.
- ALL ALTERNATIVE ARRANGEMENTS MUST BE DOCUMENTED ON OUR FUNCTION SHEET AT THE FINAL APPOINTMENT.
